

## **Terms and Conditions Early Bird Rates Draw Shire of Esperance 2023/2024 Rates Incentive Scheme**

1. Entry is open to all property owners in the Shire of Esperance who pay their 2023/24 rate notice in full by COB dates listed below.
2. All Shire of Esperance ratepayers who pay their rates in full by the relevant dates will be automatically entered into the Rates Incentive Scheme prize draw.
3. Five (5) weekly prize draws will consist of 3 cash prizes with a total prize pool of \$12,500 and 2 Local Business donations with a total prize pool of approximately \$5,000.
4. The final draw consists of multiple bonus draws donated by local businesses, Rex Airlines, and BPAY.
5. The competition will commence with the mailing or electronic delivery of the 2023/24 rate notices by Australia Post and will close on the due date being Wednesday 27<sup>th</sup> September 2023.
