YOUR PAYMENT OPTIONS



Option 1 - One Payment

Pay in one payment by 24 September 2025



Option 2 - Four Instalments

Pay over four instalments, due on the:

- 24 September 2025
- **19 November 2025**
- 14 January 2026
- 11 March 2026

Please note this option will no longer be available if payment is received after the 24 September 2025.

WHAT WE INVEST IN

Your rates enable the Shire to continue existing services, ensure ongoing maintenance of facilities and infrastructure, manage growth, and encourage economic development across new and existing areas.

When setting the Budget, Council considers the competing demands for services and facilities across the short and long term. The below provides a breakdown of the expenses over the next year.

HOW OUR REVENUE IS GENERATED

Rates contribute the most to our income, making up 28% of the Annual Budget, but they're only one source of funding. Each year the Shire receives numerous grants, uses funds from

reserves and earns revenue through fees and charges. These are a few of the ingredients used to fuel the services we provide the community.

RATES EXPLAINED

Your rates contribution helps the Shire deliver essential services to you. The Shire invests this revenue in our community with renewed and new infrastructure and facilities, as well as upgrades and improvements to existing infrastructure such as parks, roads, paths, drainage and coastal infrastructure. These funds also go toward providing a range of local services for our community including libraries; weekly waste and fortnightly recycling services; verge side waste collections; free community events such as Winter Wonderland and Edge of the Bay; parks, playgrounds and sporting

facilities; community facilities; Bay of Isles Leisure Centre; and community safety initiatives.

Each year we develop a budget to measure the cost of services and projects to be delivered in the year less other sources of funding, like grants and contributions, fees and charges. The remaining amount of money required is then divided over the total value of all rateable properties in the area. This is called "the rate in dollar". We then calculate each property value by the rate in the dollar—subject to an annual minimum rate—set by Council each year.

INTERIM RATE NOTICES

Interim Rate Notices can be issued throughout the year if the Valuer General's Office considers that the Gross Rental Value (GRV) of a ratepayers' property has changed.

Any alteration to the property could cause the GRV of your property to be re-assessed by the Valuer General's Office. Typical events which could trigger a revaluation and the need to issue an Interim Rates Notice include:

Creation of a new property eg. if a lot is created from a subdivision, amalgamation or strata title, new house on vacant land.

Demolition of a property. This is usually the first step in the redevelopment of a site and only the first in a series of interim rate adjustments.

Removal of a swimming pool

Improvements or additions to the property eg. Installation of a swimming pool, construction of a garage or carport or the addition of a bedroom.

Any changes to bin configurations will also result in an Interim Rate Notice being issued.

FAQ'S

How are rates calculated?

Council rates are determined by the revenue required to provide essential community and infrastructure services. Each ratepayer contributes a proportionate share of the costs based on their properties Gross Rental Value (GRV) or Unimproved Value (UV).

What is GRV and UV?

GRV (Gross Rental Value) is a valuation of your property, determined by the Valuer General, as an estimate of the rental income you would receive if the property was rented for one year.

UV (Unimproved Value) is also determined by the Valuer General and is based on the value of undeveloped land.

Can I object to my property valuation?

Yes. If you believe the valuation of your property is incorrect, you can lodge an objection with the Western Australian Valuer General's Office within 60 days of the issue date of your rate notice. Please refer to the reverse side of your rate notice for contact details. Please note: If lodging an objection,

rates are still required to be paid by the due date and any difference will be credited to your account.

How do I change my postal address?

You can update your postal address in 3 ways: Online: Fill out the Change of Address Form at esperance.wa.gov.au/rates

In Person: Visit the Shire Administration Building at 77 Windich Street, Esperance.

Please note: Only the registered property owner can request an address change.

Can I get a pensioner or senior rebate?

Pensioners and Seniors may be eligible for a rates rebate. To receive a rebate, a person must hold one or more of the appropriate Pensioner or Seniors cards, and on July 1 of the financial year, own and occupy the residential property as their principal place of residence. Please call the Water Corporation on 1300 659 951 with your concession card details and Water Corporation account number to update your details.

Pensioner Concession Card OR State Concession Card- Receive up to 50% rebate limited to a maximum (capped) amount of \$750.



Commonwealth Seniors Health Card together with a WA Seniors Card-Receive up to 50% rebate limited to a maximum (capped) amount of \$750.



WA Seniors Card- Receive up to 25% rebate limited to a maximum (capped) amount of \$100.

Council also accepts Centrepay from eligible pensioners. Centrepay is a free direct bill paying service offered to customers receiving payments from Centrelink. Through Centrepay you can choose to pay bills by having a regular amount deducted from your Centrelink payment making bills more manageable.

provides details of the legal requirements for each property owner within the Shire & highlights information to reduce hazards on your property as well as information on being bushfire ready.

NOTICE TO ALL OWNERS OF LAND WITHIN THE SHIRE OF ESPERANCE

Pursuant to Section 33 of the Bush Fires Act 1954. the Notice sets out the actions that you must take to prepare your property for the fire season. As a measure for preventing the spread or extension of a bush fire which may occur, all owners and occupiers of land within the Shire boundaries are required to clear firebreaks or to take measures in accordance with this Notice before 9 October 2025. Maintenance of firebreaks and measures in accordance with this Notice must be kept up to and including the 31 March 2026.

These dates are subject to change depending on seasonal weather conditions. Updates will be posted on the Shire of Esperance Facebook & Instagram accounts, as well as the website.

DRY SEASON INFORMATION

Our region is facing lower rainfall and longer dry seasons, especially from April to October. It's essential for property owners and land caretakers to effectively control the build-up of fuel loads on their properties.

TOTAL FIRE BAN

A Total Fire Ban (TFBs) is declared by the Department of Fire and Emergency Services (DFES) on a days of extreme weather where a fire is most likely to spread rapidly or if there are already widespread fires and fire fighting resources are too stretched. Occasionally TFBs may be declared outside of a fire season (such as in May or June) due to other factors such as higher temperatures and expected strong winds preceding a storm front.

On a Total Fire Ban day, it is illegal to light an openair fire or conduct any activity that could start a fire. Ignoring conditions of a Total Fire Ban can incur a \$1,000 infringement. Upon conviction, you could receive a fine of \$25,000 and/or be jailed for 12

When a Total Fire Ban is in place, it's important to be aware of what you can & can't do. For more information visit dfes.wa.gov.au/hazardinformation/bushfire/total-fire-ban.

REQUEST FOR A VARIATION

Landowners/Occupiers can apply to the Shire for permission to provide firebreaks in alternative locations or to take alternative measures to prevent the outbreak or spread of a bushfire, if any of the listed requirements of the Notice are impractical.

After consultation, the Shire may approve a variation for either a 1 year or a 3 year period. Applications for a Variation to a Firebreak must be received in writing by 24 September 2025. Fees apply.





Waste Vouchers- Keep these in a safe place! Domestic Waste Vouchers are issued annually, free of charge, with the rate notice. Replacement Waste Vouchers incur a replacement fee of \$15.


TOP 5 BIN TIPS
