

Cat Registration



The *Cat Act 2011* requires all cats that have reached six months of age to be sterilised, microchipped and registered. Owners of a cat who fail to register their animal may be liable to an on the spot fine for each unregistered animal. Registered owners of the animal must be 18 years of age or older.
