



# ESPERANCE TALENT DEVELOPMENT PROGRAM

## REGIONAL FINANCIAL SUPPORT

The Esperance District Recreation Esperance (EDRA), Esperance Talent Development Program (ETDP) is to enhance the regional talent development in Esperance and the surrounding districts. Support is available for State Sporting Associations to help develop regional athletes, coaches and umpires with specialist skills as required within the framework of the chosen sport. (You have two funding options).

### 1. CLUB DEVELOPMENT (This training must be delivered within Esperance Community).

Projects eligible for support include;

- Athlete Development-Specialist coaching and mentoring etc.
- Coach Development-Accreditation and mentoring etc.
- Umpire Development-Accreditation and mentoring etc.
- Access to sports specialist coaching and programs such as core strength training, sprint training and running technique work etc.

Examples of appropriate expenditure include: presenter fees, flights, accommodation, accreditation fees, venue and reserve hire.

To be eligible the organisation must be:

- A State Sporting Association (SSA) or high performance program, exception where no SSA is present an approved/accredited deliverer or club/association can apply.

Funds available between- **\$500 and \$2000**

Round 6: Open- 1<sup>st</sup> December 2019

Round 6: Closes- 5pm on Friday the 28th of February 2020

Note: Application must be lodged prior to an event and payment will be made after the event is acquitted.

### 2. INDIVIDUAL DEVELOPMENT (Coaching or Officiating)

Clubs/Associations can also apply for funding to send a Coach or Official to attend a (SSA approved) development sessions outside of the Esperance community. It is recommended that this development is for training above entry level for your sport (SSA's are required to conduct entry level training within our community). So if level 1 is your entry level then you could apply for funding for an individual to attend a level 2 (e.g. in Perth). Depending on the available funds nominations (per club) aren't limited in this category.

Funds available between- **\$500 and \$2000**
